# Kilimanjaro & Safari Tour - Booking Conditions & Risk Waiver Agreement

## DEPOSITS

1. To reserve a place on this tour, a **Registration Form** is to be completed by each prospective passenger. This form should be returned to *Free Spirit Adventures*. The final itinerary and price for this tour is subject to change up until such time as the booking is confirmed. You will be notified in writing of any such changes to the itinerary and /or price.
2. Once your Registration Form is received and the itinerary is confirmed; an invoice will be issued to you for a **Confirmation Deposit of \$1500.00. This is to be paid directly to Travel Managers**. If the deposit is not paid within 14 days, your booking will be cancelled. Please refer to the cancellations and refunds section of this Booking Terms and Conditions to ensure you are familiar with the cancellation charges and fees.  
Please complete and sign the Booking Form to declare that you agree to these Terms & Conditions.

3. Additional deposits may be required by airline and other ground operators and these will be advised upon confirmation of the arrangements.

## FULL PAYMENT

The final balance of payment for this tour must be received in full by Travel Managers sixty (60) days prior to departure from Australia. We therefore require the full balance of payments to be received by our Travel Manager – Andrea Turner no later than **Friday 6<sup>th</sup> May 2011**. If full payment is not received by this date, late payment fees or cancellation of your booking may result. Please contact Wayne at Free Spirit Adventures if there is any difficulty meeting with this important deadline.

## MINIMUM NUMBERS

The total tour cost per person is based on a minimum number of 10 passengers.

If minimum numbers have not been filled 60 days prior to departure, the tour may be subject to re-costing or cancellation.

Should group numbers be such that a single room is required, then a **single supplement** may be charged.

## CREDIT CARDS

An additional 3% service fee **will** be applied for use of Credit Cards. This fee is non-refundable.

## CANCELLATIONS AND REFUNDS - LAND ARRANGEMENTS

If it is necessary for you to cancel your holiday the following cancellation fees per person per arrangement apply.

Over 60 days prior to departure -	\$1000 from Confirmation Deposit + any additional deposits.
14 - 60 days prior to departure -	50% of tour cost
Within 14 days or "No Show" -	100% of tour cost

### If we cancel your trip:

If we are forced to cancel your trip for reasons beyond our reasonable control ("force majeure") we will offer you the choice of a full refund of any monies paid or an alternative trip. The Company will accept no liability for any costs incurred by you for anything other than the monies paid to us for the trip.

In addition to the charges above, should the cancellation of an individual affect the remaining passengers tour prices, we reserve the right to apply any costs, single supplement etc that is incurred, to the total cost of the tour.

Regrettably cancellation charges cannot be waived. There will be no exceptions. There are no refunds on unused services after departure from original city.

## CANCELLATIONS AND REFUNDS - AIR ARRANGEMENTS

Cancellation fees will apply as required by airlines regulations and will vary dependant upon the type of airfare utilised. Airfare prices and conditions are subject to change or withdrawal without notification until ticketed. Full payment is required before tickets can be issued. Free Spirit Adventures, Maassai Wanderings or Travel Managers cannot be held liable for any increases in prices or changes in the rules and conditions. Foreign currency airfares and airport taxes may fluctuate and are subject to the rate of exchange on date of ticket issue. Increases in airport taxes are not the responsibility of Free Spirit Adventures, Maassai Wanderings or Travel Managers.

## **PASSPORT VISA AND VACCINATIONS**

It is mandatory that you familiarise yourself with any visa and health requirements that may be applicable in the countries you are visiting. You are responsible for all entry exit health and any other documents required by laws regulations orders demands or requirements of countries visited or transited. Please note that passport and visa requirements are not the responsibility of Free Spirit Adventures, Maasai Wanderings or Travel Managers. These parties cannot be held liable for any loss or expense due to the failure to comply with the above.

## **ACCEPTANCE ON THE TRIP**

All trip participants must have a written medical clearance signed by a medical doctor. The right is reserved to accept, or decline any person as a trip participant at any time eg; their right to participate will be declined if they are under the influence of drugs or alcohol or any other physical/psychological condition which may compromise their safety. We reserve the right to ask trip participants to provide us with a medical certificate.

## **BAGGAGE:**

Allowance is limited to 20 kilos per person plus a daypack or flight bag. While every care is taken with baggage, no responsibility can be accepted for any loss, damage or delay. Baggage insurance is recommended. We recommend that you try to limit your backpack to 14kgs and daypack to 6kgs.

## **NOT INCLUDED IN THE TOUR COST**

Visas, insurance, excess baggage over 20kg (international), extra meals, laundry, drinks, souvenirs items of a personal nature, tips/gratuities. Any pre-paid airfare taxes & surcharges are clearly identified if not included in the tour.

## **TANZANIAN GROUND OPERATOR TERMS & CONDITIONS**

*Maasai Wanderings (herewith called the Company) accepts bookings subject to the following conditions:*

### **THE CONTRACT**

Your contract is with Maasai Wanderings Ltd ("the Company") of PO Box 14035, Arusha, Tanzania. The terms and conditions of all agreements made with the Company shall be subject to and governed by Tanzanian Law. When making a booking you accept that you have read and understand all the booking conditions and agree to abide by them.

### **MAKING A BOOKING**

We require a completed booking form and a deposit of \$1500 AUD per person. The person signing the booking form does so on behalf of all other persons mentioned on the form. A contract exists when we issue written confirmation of your booking. We reserve the right to refuse any booking at our discretion.

### **PAYING FOR THE TRIP**

The full balance of payment is due 60 days before the departure date of any trip. If this balance is not received the Company reserves the right to treat your booking as cancelled. Travel costs may be affected by external factors beyond our control such as exchange rates, National Park Fees and government imposed taxes. We reserve the right to impose any such surcharges on the cost of the trip. However should any such increases be greater than 5% you will be informed and may cancel your trip within 7 days of notification and be entitled to a full refund of any monies paid.

### **ITINERARY CHANGES**

Whilst we will make every reasonable effort to adhere to our itineraries you must realize that the nature of adventure travel in Africa may require changes in travel plans for which the Company accepts no responsibility. Reasons for changes to itinerary may include but are not limited to; safety, interruptions to transportation, political unrest, prevailing weather conditions and the needs of the group. We will advise you of any changes as soon as we become aware of them.

If you request or require itinerary changes you may be liable for any costs we incur to facilitate these (see Insurance below).

### **ACCEPTANCE OF RISKS**

Adventure travel in Africa involves a degree of risk. Such risks may include amongst others, injury, death, disease, accident, loss of property, inconvenience, delays and discomfort. Please understand that you must accept these potential hazards and that the Company, Free Spirit Adventures and Travel Managers will not be liable for any such risks or claims. The Company, Free Spirit Adventures and Travel Managers will also not be liable for the consequences of strikes, industrial action, wars, civil strife, terrorist activity, adverse weather conditions, natural disasters, other untoward occurrences or any uninsured losses of your property.

## **INSURANCE**

You must be adequately insured for any trip as a condition of booking. This should include cover for personal accident and medical expenses, including repatriation, and you are strongly advised to include cover for cancellation, curtailment and loss of property. Please carry a copy with you on the trip and leave a copy with a relative in your country of origin.

You are at liberty to organise your own travel insurance but please ensure that there is adequate inclusions for trekking, including medical emergency evacuation.

## **TRIP LEADERS**

Our leaders and guides are there to ensure your trip runs as smoothly as possible. They will at all times be acting in the best interests of the group. Should the behavior of any member of the group jeopardize the safety and well-being of the group the leader, or other company representative, may ask that member to leave without recourse to any refund. By signing the booking form you indicate acceptance of the leader's authority to make such decisions affecting the group and individuals.

## **COMPLAINTS**

If you have any complaint against the Company, Free Spirit Adventures or Travel Managers you should in the first instance inform the trip leader or relevant company representative whilst on the trip so that the complaint may be addressed at the time, and where possible dealt with to your satisfaction. Any further complaint must be made in writing to the Company, Free Spirit Adventures or Travel Managers within 14 days of the end of the trip.

## **ACCEPTANCE OF BOOKING CONDITIONS & RISK AWARENESS / LIABILITY WAIVER**

I the undersigned accept the booking conditions. I confirm that I have read and understand all the information provided relating to this trip and agree to abide by the booking conditions. I understand and accept that adventure travel in Africa involves greater risk of misfortune and danger than conventional holiday travel in more developed countries and confirm that I will obtain adequate insurance to cover such risks.

In particular I acknowledge that I have been advised by Free Spirit Adventures (FSA) and Travel Managers (TM) and Maasai Wanderings (MW) of the following matters in relation to my upcoming Kilimanjaro trip with FSA/TM/MW:

I have been advised that travel and trekking are inherently dangerous activities. I may be killed, injured, incapacitated and experience pain, illness and suffering. I may experience loss, damage or theft of my property. Any of the above may not be FSA /TM/MW's fault or the fault of anyone. These incidents may be caused by others in my party, employees or directors of FSA /TM or MW, their subcontractors or even my guide, may be caused by environmental factors, or even just physical or mental exhaustion which can happen at any time on my trip. There is no way of predicting all the hazards I may face. While FSA and MW will take reasonable precautions to minimise the risks, there is no way FSA and MW can guarantee my safety on this trip 100%.

I acknowledge that the areas we will be travelling in Africa are often remote with little or no immediate medical support. In some remote areas self-rescue is the only option. My guide may need to begin first aid appropriate to the remoteness of the area and the nature of my ailment. By signing this document I certify that I have read and understood these risks and they are acceptable to me.

I also agree not to seek compensation, financial or otherwise from any incident that might occur during or associated with the trip, from FSA, TM or MW, its directors, officers, employees or subcontractors.

FSA, TM and MW and their agents including employees, guides, leaders, subcontractors and porters shall not be liable for loss, death or injury, to any of its clients or loss or damage or delay to their baggage, personal effects or other property arising from the following:

1. Acts of God including but not limited to Landslides, Ice Cliff Collapse, Avalanche, Earthquakes, Flooding and Fire;
2. Civil disturbances of any nature including but not limited to War, Revolution, Riots, Strikes or Labour Shortages;
3. Environmental Factors such as changes to trails rivers and valleys, loose rocks, unstable ground, bad weather;
4. Any other circumstance beyond our control and responsibility.

## **ACCEPTANCE**

I have read & understood the Risk Awareness / Liability Waiver. I understand and accept the risks that have been explained to me, I hereby waive my right to bring any legal claim against the Enright Group Pty Ltd, The Enright Family Trust t/a Free Spirit Adventures, Travel Managers and Maasai wanderings, even where FSA/TM/MW and its Employees, Agents or Contractors would otherwise be deemed liable due to Gross Negligence, Breach of Contract or otherwise as outlined above.
